The Treasurer advised the Board that the notice requirement of R.C. 121.22 and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting.

WHEREAS, pursuant to Ohio House Bill 197, signed into law by Governor DeWine on March 27, 2020, members of a public body may hold, attend, and participate in meetings by means of teleconference, video conference, or any other similar electronic technology; and

WHEREAS, in conformance with the Executive Orders of the Governor's Office and the Ohio Department of Health, issued in March, 2020, prohibiting large gatherings of people and closing school buildings in response to the Coronavirus pandemic, the Board has determined to exercise its authority to hold today's meeting by means of a video conference over the internet; and

WHEREAS, current Board Policy 0167 provides that a Board member must be physically present at a Board meeting to vote; and

WHEREAS, current Board Policy 0169.1 provides that the Board will offer public participation to members of the public at a Board meeting; and

WHEREAS, to ensure compliance with its own Policies, the Board desires to temporarily remove the aforementioned requirement from Board Policy 0167, and to suspend Board Policy 0169.1 in its entirety, for the duration of the period of emergency declared by Executive Order 2020-01D.

THEREFORE, BE IT RESOLVED, by the Board of Education of the Garaway Local School District, Tuscarawas County, Ohio, that:

Section 1. Pursuant to Ohio House Bill 197, during the period of the emergency declared by Executive Order 2020-01D, issued on March 9, 2020, but not beyond December 1, 2020, unless the period of the emergency continues beyond that date, Board Policy 0167 - "Voting" shall be revised, so as to remove the following sentence: "A Board member must be physically present at the meeting to vote." The intent of this action is to permit members of the Board to vote during public meetings held by means of teleconference, video conference, or any other similar electronic technology, in which such Board members are participants.

During the period of the emergency declared by Executive Order 2020-01D, issued on Section 2: March 9, 2020, but not beyond December 1, 2020, unless the period of the emergency continues beyond that date, Board Policy 0169.1 - "Public Participation at Board Meetings" shall be suspended. This action is taken because not all members of the public have the technological ability to participate in meetings held electronically. This action does not prohibit public comment during Board meetings. Rather, public comment may be heard at the Board's sole

WHEREAS, the Board has issued supplemental employment contracts and the parties have agreed that the Board will pay employees their supplemental contracts, in accordance with Section 1 of this Memorandum of Understanding, despite the COVID-19 pandemic which has resulted in the cancellation or suspension of certain student athletics and extracurricular activities

NOW, THEREFORE, the parties hereby agree as follows:

- The Board shall compensate all individuals with whom it had entered into a supplemental contract or pupil activity
 contract for the 2019-2020 school year to supervise or direct extracurricular pupil activity programs and athletics,
 including full-year and spring contracts, as follows: head coaches shall be paid their full stipend, whereas assistant
 coaches shall be paid one half of their set stipend.
- 2. Except as provided in this Memorandum of Understanding, all other terms and conditions of the Agreement shall remain in full force and effect. Nothing in this Memorandum of Understanding shall be construed to create or result in a past practice, or modification of the bargaining unit. This Memorandum of Understanding represents the entire agreement of the parties with respect to its subject matter and may only be amended by a signed writing.
- 11. Resolution for the payment of supplemental and pupil-activity contracts during the pendency of executive order 2020-01D, ODH Director's Order regarding the closure of all K-12 schools in Ohio and future orders requiring District response.

WHEREAS, the COVID-19 pandemic and the resulting State of Ohio Executive and Department Orders, as well as the following related Agency Orders, necessitate that the Board of Education pass the following resolution:

- 1. Governor Mike DeWine's March 10, 2020 Executive Order 2020-01D.
- Ohio Department of Health Director Amy Acton, M.D., MPH March 14, 2020 Order In Re: Order the Closure
 of All K-12 Schools in the State of Ohio.
- 3. Ohio High School Athletic Association Order, March 13, 2020.
- Ohio Department of Health Director Amy Acton, M.D., MPH March 30, 2020 Amended Order In Re: Order the Closure of All K-12 Schools in the State of Ohio, through 11:59 p.m. on May 1, 2020;
- Any other orders or directives of duly authorized Ohio State Officials in relation to COVID-19 that may occur during the pendency of Executive Order 2020-01D; and

WHEREAS, on March 14, 2020, Director Acton ordered that all school buildings that provide any kindergarten through grade twelve instruction in the State of Ohio be closed to students beginning at 12:01 a.m. on March 17 through 11:59 p.m. on April 3, 2020; and,

WHEREAS, on March 30, 2020, Director Acton amended her March 14, 2020 Order, and extended the closure to students of all school buildings that provide any kindergarten through grade twelve instruction in the State of Ohio through 11:59 p.m. on May 1, 2020; and

WHEREAS, on March 14, 2020, and her Amended Order of March 30, 2020, Director Acton further clarified that such closure "does not include administrators, teachers, staff, vendors, or contractors of a school," and that the "administration of each school shall determine the appropriate level of access to the school during the closure."

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Garaway Local School District, Tuscarawas County, Ohio, that:

Section 1: Payment of Supplemental/Co-Curricular/Extracurricular Contracts

The Board hereby authorizes all individuals with whom it had entered into a supplemental contract or pupil activity contract for the 2019-2020 school year to supervise or direct extracurricular or co-curricular pupil activity programs and athletics, including full-year and spring contracts, to be compensated. Head coaches shall be paid in full, whereas assistant coaches shall be paid one half of their set stipend. The Treasurer is hereby authorized and directed to pay said contracts, including during the cessation of all sports, extracurricular, and co-curricular activities due to the COVID-19 pandemic.

Section 2: Meeting to Confer with GTA Regarding Modified Duties

The Board hereby approves the Memorandum of Understanding attached hereto with the Garaway Teachers' Association regarding the payment of supplemental contract or pupil activity contract for the 2019-2020 school year, which shall be incorporated herein by reference. Nothing in the Memorandum of Understanding or this Resolution shall be construed to create or result in a past practice of the Board.

Section 3: Treasurer's Authority

By this action, the Board hereby appropriates the funds necessary for the execution and implementation of this resolution and further authorizes and directs the Treasurer to encumber and pay any funds necessary for the implementation of this resolution.

Section 4: Board Policy Emergency Suspension

By this action, the Board hereby suspends, for the 2019-2020 school year only, any and all Board Policies that may conflict with the authority granted herein.

Section 5: Compliance with Public Meetings Law

It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code and Section 12 of H.B. 197.
