WHERFAS, as a result of this competitive RFP the winner will supply the School District with natural gas at a price and term as endorsed by OME-RESA; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE Garaway Local School District, COUNTY OF TUSCARAWAS, STATE OF OHIO, as follows:

The Board of Education does hereby authorize the signature of the Treasurer, Superintendent or their designated alternate to execute the purchase of natural gas between the School District and the winner of OME-RESA and Titan Energy's natural gas procurement RFP.
