- 2. Contract with Comdoc for Managed Print Services for 60 months at monthly fee of \$0 + \$0.012 per black impression and \$0.10 per color impression. (Note: Color printing is programmed to print through the District's Central Office copier for cost savings.)
- 3. Agreement with the Village of Sugarcreek to divide the cost of a District Resource Officer. Garaway's portion of the agreement will be \$9,831.80 per calendar year through December 31, 2018.
- 4. Building valuations as determined by Duff and Associates and to adjust property insurance valuations with Ohio School Plans.
- 5. Replacement of 58 windows in the 1930 portion of the High School Building at a cost of \$22,404.00. The ProVia windows will be purchased through Keim Lumber as their distributor with a significant discount from ProVia. - 6. Upgrade to LED lighting at the Garaway 7-12 Building at an estimated cost of \$34,259.00 for materials. An estimated \$10,469.32 rebate will be applied leaving the total cost of materials approximately \$23,789.68. Installation will be done by Garaway Building & Grounds. Project to be completed during the summer of 2018. This lighting upgrade will result in an estimated yearly energy savings of \$4,428.00.
- 7. Replace the Garaway 7-12 bell/public address system by Frontier Communications at a cost of \$21,380.30.
- 8. Approved the Resource Officer job description.
- 9. Participation in the OSBA CompManagement, Inc., workers compensation group rating program for calendar year 2019, enrollment fee of \$2,655.00
- E-Rate Contract with Omeresa Internet Access for FY19 at a cost of \$80,136.00 less applicable E-Rate discounts.
