WHEREAS, the COVID-19 pandemic and the resulting State of Ohio Executive and Department Orders, as well as the following related Agency Orders, necessitate that the Board of Education pass the following resolution:

- 1. Governor Mike DeWine's March 10, 2020 Executive Order 2020-01D and subsequent Orders;
- Ohio Department of Health Director Amy Acton, M.D., MPH Orders closing all school buildings that provide kindergarten through grade twelve instruction in the State of Ohio to students from March 14, 2020 through the end of the 2019-20 school year;
- Any other orders or directives of duly authorized Ohio State Officials in relation to COVID-19 that
 may occur during the pendency of Executive Order 2020-01D; and
- WHEREAS, the Board employs teaching and nonteaching employees pursuant to R.C. 3319.08 and R.C. 3319.081; and
- WHEREAS, R.C. 3319.08(B) states that "teachers must be paid for all time lost when the schools in which they are employed are closed due to an epidemic or other public calamity"; and
- WHEREAS, R.C. 3319.081(G) states that "all nonteaching employees...shall be paid for all time lost when the schools in which they are employed are closed owing to an epidemic or other public calamity"; and
- WHEREAS, in addition to employing its own employees, the Board enters into a service agreement with the East Central Ohio Educational Service Center ("ECO-ESC"), whereby the ECO-ESC provides its employees to perform unique and specialized services for the Board; and
- WHEREAS, the Board wishes to honor its 2019-2020 school year service agreement with the ECO-ESC and compensate those employees which the Board utilizes on a regular basis, including a Long-Term Substitute / Secretary for the Garaway Virtual Academy; and
- WHEREAS, in adopting this resolution, the Board seeks to follow the Auditor's guidance from the "Coronavirus (COVID-19) Frequently Asked Questions" and the April 28, 2020 School Treasurer Virtual Roundtable, wherein the Auditor states that "as a matter of best practice, the [Auditor] strongly encourages members of the governing authority to approve decisions regarding employee pay during this pandemic."
- NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Garaway Local School District, Tuscarawas County, Ohio, that:
- Section 1: Approval of Payment to Employees During the COVID-19 Pandemic
 - (a) In accordance with R.C. 3319.08(B) and 3319.081(G), except for substitutes and employees hired on an "as needed basis" and except as set forth in Section 1(b), the Board hereby authorizes compensation to its regular teaching and nonteaching employees "for all time lost" from March 14, 2020 until June 30, 2020, while the schools in which they are employed are closed to students during the 2019-20 school year as a result of the COVID-19 pandemic. Therefore, the Board authorizes compensation to its regular teaching and nonteaching employees whether or not they were performing their assigned duties.
- (b) Conversely, any employee employed from March 14, 2020 until June 30, 2020, who was suspended without pay, on an unpaid leave from his/her employment including, but not limited to, workers' compensation leave, unpaid Family and Medical Leave Act leave, maternity/paternity leave, sabbatical leave, military leave, or any other form of unpaid leave, who typically would not be eligible to be paid during this period of time, is not eligible for this compensation under R.C. 3319.08(B) and 3319.081(G).
- Section 2: Authorization to Honor the 2019-2020 ECO-ESC Service Agreement
- The Board hereby authorizes the Treasurer to honor the 2019-2020 service agreement with the ECO-ESC and compensate those employees which the Board utilizes on a regular basis, including the Long-Term Substitute / Secretary; School Nurse; and One-on-One Special Education Aide. The Treasurer is hereby authorized and directed to pay said contracts.
- Section 3: Treasurer's Authority
- By this action, the Board hereby appropriates the funds necessary for the execution and implementation of this resolution and further authorizes and directs the Treasurer to encumber and pay any funds necessary for the implementation of this resolution.
- Section 4: Compliance with Public Meetings Law
 - It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code and Section 12 of H.B. 197.
