WHEREAS, state and federal officials have historically honored the symbolic relationship between state responsibility and local control of school districts; and

WHEREAS, beginning in the 1990s state officials began to erode that symbiotic relationship; and

WHEREAS, the No Child Left Behind (NCLB) federal legislation emboldened by the Rate to the Top (RttT) federal program as administered by state officials has usurped local control in several critical areas; and

WHEREAS, NCLB and RttT have been replaced by Every Student Succeeds Act (ESSA); and

WHEREAS, ESSA, although possibly less onerous in terms of intrusion into boardrooms and classrooms, continues to test and punish philosophy as well as limit local control; and

WHEREAS, the arbitrary top-down, test-based accountability system assumes that rigorous instruction and testing will replace the need for essential financial resources as required by the Ohio Constitution; and

WHEREAS, changing standards and cut scores on an annual basis is inexcusable and counterproductive; and

WHEREAS, education and accountability have greater scope and depth than test

WHEREAS, the current accountability system is too narrow and does not reflect important and essential student outcomes; and

WHEREAS, the single score measurement is an invalid assessment with false pretense claiming accountability and transparency; and

WHEREAS, an accountability system that labels and punishes public schools in the belief that such will improve student learning is invalid; now

THEREFORE, BE IT RESOLVED the Garaway Local School District Board of Education assigns and strongly disapproves of the current state accountability system; and

BE IT FURTHER RESOLVED that the state of Ohio should formulate a process (beyond the ESSA Stakeholders meetings) that meaningfully involves parents, board members, school administrators, teachers, other school patrons, business officials and union officials to develop an accountability system to truly measure how well public schools are fulfilling their primary role of developing productive citizens; and
