Resolution to rescind Sections 2 through 6 of Item #2 of New Business from the June 10, 2013, Garaway Board of Education Meeting: Resolution to permanently suspend and rename school buildings. WHEREAS, Section 3313.49 of the Ohio Revised Code authorizes a board of education to temporarily or permanently suspend any school building due to disadvantageous location or any other cause; and WHEREAS, it is necessary for the Board to permanently suspend Dundee and Ragersville Elementary School Buildings at the conclusion of the 2013-2014 school year due to financial reasons and the educational benefit of the students; and WHEREAS, the Board wishes to rename Miller Avenue and Baltic School Buildings and change the grades that are assigned to those buildings at the conclusion of the 2013-2014 school year. NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Garaway Local School District, Sugarcreek, Ohio, that: Section 2: Due to financial reasons, and the educational benefit of the students, the Board hereby shall permanently suspend the Dundee and Ragersville Elementary School Buildings at the conclusion of the 2013-2014 school year. Section 3: The Board and its Administration are hereby authorized and directed to take any and all actions necessary to suspend/close the Ragersville and Dundee Elementary School Buildings. Said actions shall include, but not be limited to assigning the students residing within the territory of the Dundee and Ragersville Elementary Schools to other school buildings and securing new Information Retrieval Numbers from the Ohio Department of Education. Section 4: At the conclusion of the 2013-2014 school year, Miller Avenue School Building will be renamed Garaway Primary housing grades K-3; and Baltic Elementary School Building will be renamed Garaway Intermediate housing grades 4-Section 5: The students who are to be in grades K-3 beginning with the 2014-2015 school year shall be assigned to Garaway Primary (K-3). Section 6: The students who are to be in grades 4-6 at the beginning of the 2014-2015 school year shall be assigned to Garaway Intermediate (4-6) Discussion: Rob Coburn addressed Jeremiah Johnson's remarks from the Public Participation and said that they would rescind the motion and then address it with the public. Jim Parson said that when he makes a decision it is based on the education of the students first. He believes that we should challenge every student to best meet their needs. He asked for comments from the audience. Leslie Yoder asked if the decision had to be made that night. She questioned how

> decision was being made rashly? Mr. Coburn acknowledged her comment and said he went to accountants and attorneys to look at the numbers. The platform they ran on was to stop this and to get people together to discuss what's best. Jeremiah Johnson asked if the administration told him that keeping the buildings open
